The chair advised that a Public Hearing was held on this agenda item earlier and was open to discussion and Public Input at that time.

(The above and foregoing ordinance, upon final approval by the President, or the Council in case of veto by the President, shall be published in full in the Official Journal by the Clerk of the Council within fifteen (15) days of its adoption and shall be recorded in full in the Livingston Parish Council Ordinance Book No. 5)

The chair addressed agenda item 10, “Parish President’s Report” and called upon the Parish President, Layton Ricks.

The Parish President addressed agenda item 10a, “Amend current 2017 Road Program”, and advised that the current road program needed to be amended by having one (1) road changed out, concurring this with Billy Taylor, road project engineer, located in the audience. He further advised that there were twenty-eight (28) roads that had been repaired or over-layed, being roughly sixteen (16) miles, at approximately six point five million dollars (\$6,500,000.00). He explained that they were in the final stages, with just a few punch items that were needed. He called upon Billy Taylor of McLin Taylor, Inc. Engineering and Land Surveying and Parish Road Program Engineer. Mr. Taylor explained that there was one (1) housekeeping item that was needed by amending the program with one (1) road. He reminded the Councilmembers that they had recently added South Satsuma, Bonnie Bleu and Texas Street to the program. Since then, there has been a road transfer program going on inside the town of Livingston and the state of Louisiana will now be doing Texas Street and have requested that the Parish overlay Cedar Street, which is shorter and will cost less money. Mr. Taylor asked the Councilmembers to adopt a resolution to amend the current 2017 road program by removing Texas Street from the list and add Cedar Street.

MOTION was made by Jeff Ard and duly seconded by Tracy Girlinghouse to amend the current 2017 Road Program list by removing Texas Street and adding Cedar Street, both being located in Council District 1.

Thereupon the chair declared that the Motion had carried and was adopted.

The Parish President addressed agenda item 10b, "Approve/Ratify 2019 Road Program Bids", and explained that this will include roughly seventeen (17) roads, roughly eighteen (18) miles, the low bid was by R.J. Daigle of seven million three hundred ninety-eight thousand one hundred thirty-eight dollars and forty cents (\$7,398,138.40), being roughly one point two five million (1.25 million) less than the next bid. He further explained that this may be because of relocation and he felt that it was a real good value and he asked the Councilmembers to approve that bid.

Thereupon the chair declared that the Motion had carried and was adopted.

The Parish President requested to update the Councilmembers about Tropical Storm Barry and advised of the measures that the Parish was taking in preparation for the storm. He instructed of the number of sand bags and sand that was ready for distribution, he had increased his staff to work shift work for the Department of Public Works throughout the upcoming weekend, the tentative plans for the Office of Homeland Security and Emergency Preparedness, their combined efforts with gravity drainage districts to blow out culverts, encouraged citizens to pick up lightweight things in their yards for possible high winds that may be coming, and the collaboration with the Sheriff's office with inmate labor for sandbagging. He encouraged citizens to call if they had any complaints or issues that needed to be addressed and cited the phone number (225)686-3996 for these calls. He acknowledged that they would have a clearer picture of what the storm may do within the next day.

Councilman John Wascom questioned if that phone number would be available during late night hours for the public to call. Mr. Ricks advised that it would. He discussed how people were nervous and scared about the pending weather event because of the 2016 Flood and are still feeling the impact of that flood. He further directed that his office would be in touch with the Councilmembers throughout this weather event.

The chair addressed agenda items 11, a through h, "Planning Commission Recommendations" and called upon Mr. Sam Digirolamo, Planning Director.

Mr. Digirolamo acknowledged the Councilmembers and explained the agenda items presented.

Councilman Garry Talbert asked if agenda item 11a, "Livingston Wood Products, Subdivision without Improvements", if this development would be done under the new standards recently adopted. Mr. Digirolamo reassured him that it would, and has been done, since the Council adopted the new standards.

Many years ago, papers were drawn up from a deed to transfer property and a map was never drawn. Now, they desired to do a map, perhaps to sell the property, whereby putting an additional lot on the property, therefore, requiring a waiver to approve the plat.

Thereupon the chair declared that the Motion had carried and was adopted.

Mr. Digirolamo addressed agenda 11c, “Juban Parc, 4th Filing, Preliminary Plat”, and advised that the Planning Commission recommended to approve this agenda item, contingent upon it being included on the preliminary plat. He furthered explained that the Council had recently adopted an ordinance that mandates two (2) entrances in and out of subdivision developments and this plat was in the first go-around, so the engineers, as well as himself, will recognize the plat being approved originally, years ago. The development does not have two (2) entrances, however, there is an emergency exit. Mr. Digirolamo requested that the engineer, Mr. Billy Taylor of McLin Taylor, Inc., come from the audience to further explain. Mr. Taylor advised that the main entrance is off of Brown Road and is a big development being built in phases. This phase had been previously approved, but not built yet. There is a second entrance that goes through the neighboring school and comes out on Brown Road. The question had been raised, could this be a second entrance because it is locked from time to time? The developer is requesting that since this was previously approved in 2007, can the Council go by the rules that applied back then for approval? However, the developer has a piece of property to the south of this, that he can use to tie in to and has agreed to put another entrance in there. Mr. Taylor finished his explanation and advised that they would be putting in a second entrance. Councilman Tracy Girlinghouse concurred with Mr. Taylor’s statements and wished to make the motion.

Mr. Digirolamo addressed agenda item 11e, "Deer Lakes Subdivision, Waiver Request on Setbacks" and advised that he and Forte and Tablada had inspected this development in 2013, being a residential subdivision, and everything was fine. Unfortunately, the owner/developer went bankrupt and this developed subdivision has now been sold and has a new owner. The chair advised that this was in his district and he had gone and looked at the development. He advised the Councilmembers that this was going to actually be an improvement as the subdivision is unkept and nasty looking, and the new developer will be making the site really nice when he is done. Some of the Councilmembers questioned why the waiver request was needed. Mr. Digirolamo explained that a twenty-five-foot (25') setback is required on a residential home. The new developer is placing modular homes in the subdivision development and needs the extra five feet (5') to put the modular home on the lots. Councilman Keen requested the reason that three (3) of the Planning Commission members had voted no at the Planning Commission meeting to recommend this for approval to the Councilmembers. Mr. Digirolamo advised that he could not answer that and did not know why they voted in opposition. Councilman Talbert asked if the roads in the subdivision were private? Mr. Digirolamo and the chair both advised that they roads were blacktopped and had been accepted into the parish maintenance system. The developer was requesting that the drainage remain private, to be maintained developer, to which Mr. Digirolamo did not have a problem with. He further explained that it was a nice subdivision. The chair asked if there was any other discussion from the audience or the Councilmembers. Having none, the chair called for the vote.
