Minutes of the Livingston Parish Council Livingston, Louisiana November 21, 2017

The Livingston Parish Council met in regular session duly called, advertised, and convened at its regular meeting place, the Parish Council Chambers, Governmental Building, 20355 Government Boulevard, Livingston, Louisiana, on Thursday, November 21, 2017, at the hour of six (6:00) o'clock p.m. with the following Livingston Parish Council members present:

The chair called the meeting to order and called upon Councilman Garry "Frog" Talbert. The chair addressed agenda item 13, "Approval of Judicial Building Fund service charge fee of \$10.00 (per filing), as mandated by R.S. 13:1910(e), for the Ward II Marshal's office, Introduction of ordinance – John Wascom" and called upon Councilman John Wascom. Councilman Wascom indicated that he had been approached by City of Denham Springs, Ward II and Ward 7, Clerk of Court's office and explained the need for the proposed fee and called upon Joe Shumate, Denham Springs Ward II Marshal. Mr. Shumate explained that the Louisiana Supreme Court bestowed a grant in the amount of two hundred thousand dollars (\$200,000.00) to their court that would be used to update their computer technology by the first of the year. The ten-dollar (\$10.00) fee would help pay for that technology, training and updates. The chair called upon the Council clerk to read the ordinance by title.

He further explained that the Permit Department had been cited by the auditor several times for permit numbers that were inconsistent numerically because of antiquated software. He explained the new software in great detail and why the fee increase was needed.

Both councilmen suggested that a formula for the Councilmembers' salary be created

based on seventy-five percent (75%) of what Louisiana's State Legislature sets by revised statute. The chair allowed Councilman Garry "Frog" Talbert to give a very lengthy explanation of the history of the Council's pay and how the amendment to the proposed ordinance would be considered and carried out. The chair explained in great detail the current standard of the Councilmembers' pay rate and the state of Louisiana's standard maximum that is allowed. The chair allowed an open discussion.
