

**Minutes of the Livingston Parish Council
Livingston, Louisiana
January 23, 2020**

The Livingston Parish Council met in a regular session duly called, advertised, and convened at its regular meeting place, the Parish Council Chambers, Governmental Building, 20355 Government Boulevard, Livingston, Louisiana, on Thursday, January 23, 2020, at the hour of six-thirty (6:30) p.m. with the following Livingston Parish Council members present:

In the absence of the chairman, Councilman Shane Mack, according to Section 2-07 of the Home Rule Charter, "*Council Meetings and Rules*", the co-chair shall preside. Therefore, Councilman Garry "Frog" Talbert as the co-chairman called the meeting to order as the pre-siding officer with no objection.

The co-chair addressed agenda items 5a and b:

- 5. Election of officers:**
a. Council chair
b. Council co-chair

He advised that the first officer that would be elected would be Council chair and he wished to open the floor for nominations.

Councilman Randy Delatte stated that he wished to nominate John Wascom.

The pre-siding co-chair advised that Mr. Delatte made a motion to nominate Mr. Wascom for chair and asked if there was anyone who wished to make a second to his motion.

Mr. Delatte was quick to invoke point of order to this and instructed that a second was not required per Robert's Rules of Order.

The pre-siding co-chair asked Mr. Chris Moody, Parish Legal Counsel and Parliamentarian for direction in this matter of parliamentary procedure, as a point of order occurs when someone draws attention to a rules violation in a meeting of a deliberative assembly and there is a query in a formal debate or meeting as to whether correct procedure is being followed.

Mr. Moody advised that his statement was correct, a second was not needed for a nomination, and he could continue to take nominations from the members as they came forth.

Councilman Jeff Ard made a motion to nominate Councilman Garry Talbert for chairman.

The pre-siding co-chair stated that the motions had been made. He qualified that there had been a motion made for Mr. Wascom, and then also for himself as chairman, and he then called for any other nominations that may be presented on the floor at that time.

The pre-siding co-chair questioned how the vote would be called as did the Council clerk. Mr. Moody advised that the Council clerk would advise that the Councilmembers would announce their vote when the roll would be called.

Thereupon the pre-siding co-chair declared that the Motion had **TIED** and therefore **CONSIDERED FAILED.**

The pre-siding co-chair questioned what to do of Mr. Moody since there was a tie vote. Mr. Moody advised that the Home Rule Charter did not provide any resolution in this type of situation. He suggested that they wait until they have a full membership back or they nominate a temporary chairman for that evening.

Councilman Randy Delatte advised that he wished to nominate Mr. Wascom as temporary chairman. Councilman Tracy Girlinghouse questioned if the Council could vote for their co-chair and that person could serve as the presiding chair to run the meeting?

Mr. Moody advised that was permissible in the absence of a chairman.

The co-chair, as the presiding officer of the meeting, stated that the next item of the agenda was to elect a co-chair for the year. However, there was still a motion for a temporary chair on the floor and he questioned how they should proceed?

Mr. Moody advised that he felt that it would be appropriate to make a motion of how they would like to proceed and asked if there was a motion for co-chair?

Councilman Maurice "Scooter" Keen advised that he wished to make the motion to vote on the co-chair. The pre-siding co-chair requested if there was a second to his motion. Councilman Jeff Ard requested to make the second to that motion.

Councilman Randy Delatte called point of order once again to educate the Councilmembers that they were incorrect in their vernacular of the use of the word "co-chair" and they should be using the terminology, "vice-chair". Mr. Moody advised that while he was correct, the Councilmembers just have always used the term "co-chair" without any rebuke.

The pre-siding co-chair then changed his call for the vote to state that the motion was to move forward and proceed with nominations for vice-chair. He asked if any challenged this motion and wished to make a substitute motion? Having none, he asked the Council clerk to call for the vote. Councilman Randy Delatte requested to educate everyone on the differences between a co-chair and a vice-chair. The pre-siding co-chair abrogated his request and asked of him to let them get through the voting process before he would get to all of that, to which no one objected, and he called for the vote.

Thereupon the pre-siding co-chair declared that the Motion had **TIED** and therefore **CONSIDERED FAILED.**

Councilman Randy Delatte stated that he wished to go back to his original motion to vote for a temporary chair.

The pre-siding co-chair asked if there was a second to the motion to vote for a temporary chair?

Mr. Moody as the Council's Parliamentarian advised that there was another option that they could have, to vote this motion down, or to entertain a substitute motion. The chair called for someone to second to the motion, and Councilman Gerald McMorris made that call.

Councilman Jeff Ard requested to make a substitute motion to continue running the meeting that night with a second to that motion by Councilman Maurice "Scooter" Keen.

Councilman Delatte requested to speak and asked if the chairman that they were voting on was a "temporary chair" for that night only - -was that correct?? To which his was answered in the affirmative. Councilman Delatte then questioned what was so different from that motion than the motion that he had just made?

The pre-siding officer gave detailed explanation and other members requested that they move on. He further explained that a "Yes VOTE" would leave him as chair for the rest of the night and if the vote

does not carry then they will vote on if they move to vote for a temporary chairman. He further explained at that point and time, they will have to have a nomination and vote again.

Thereupon the pre-siding co-chair declared that the Motion had **TIED** and was therefore **CONSIDERED FAILED**.

The Councilmembers looked to Mr. Moody for direction and any solutions he may offer at this impasse that they had come to.

Mr. Moody indicated that he did not have any solutions other than what he had already offered earlier in the meeting. The members could pick someone else that had not been previously nominated.

Councilman Tracy Girlinghouse suggested that the Councilmembers agree to nominate Councilman Jeff Ard for just that evening.

Councilman Randy Delatte called on the pre-siding co-chairman, Councilman Garry Talbert, and asked if they were going by Robert’s Rules of Order, and he said that their standard operating procedures says that they are, it says that the chairman should show leadership ability and not influence the vote in any case when it comes to a tie like that. He said that if you abstain from voting or not try to influence the vote it would not be for a temporary chair and that would be in the best interest of the meeting.

Councilman Girlinghouse stated that his wishes were to make a motion to designate Mr. Ard as temporary chair for the night and Councilman Maurice “Scooter” Keen advised that it was his desire to second that motion.

Councilman Garry Talbert, who was pre-siding as the chairman, called upon the Council clerk. He requested that the Council clerk move his vote down to be called upon and counted last at the end of the roll. The Council clerk acknowledged his request and called his name last in the roll call for the vote.

The chair addressed agenda item 10, “Adopt a resolution granting approval to Fire Protection District No. 5 to call and hold an election on Saturday, May 9, 2020 to authorize the levy and collection of a service charge in an amount not to exceed \$32.00 per annum for each single family residential structure, not to exceed \$100.00 per annum for each multi-family residential structure and not to exceed \$150.00 per annum for each commercial structure for a period of ten (10) years for the purpose of providing fire protection services – Jim Ryan”.

Mr. Jim Ryan was not able to attend the meeting that evening, but Councilmen R.C. “Bubba” Harris and Maurice “Scooter” Keen were able to elaborate on what the resolution entailed.

L.P. RESOLUTION NO. 20-025

A Resolution granting approval to Fire Protection District No. 5 of the Parish of Livingston, State of Louisiana to call and hold an election on Saturday, May 9, 2020 to authorize the levy and collection of a service charge in an amount not to exceed \$32.00 per annum for each single family residential structure, not to exceed \$100.00 per annum for each multi-family residential structure and not to exceed \$150.00 per annum for each commercial structure for a period of ten (10) years for the purpose of providing fire protection services.

WHEREAS, Fire Protection District No. 5 of the Parish of Livingston, State of Louisiana (the "*District*") adopted a Resolution on December 10, 2019 (the "*District Resolution*") ordering and calling a special election to be held in the District on Saturday, May 9, 2020, for the purpose of levying and collecting a service charge in an amount not to exceed \$32.00 per annum for each single family residential structure, not to exceed \$100.00 per annum for each multi-family residential structure and not to exceed \$150.00 per annum for each commercial structure for a period of ten (10) years for the purpose of fire protection services (the "*Service Charge*"), all in the manner conferred by Article VI, Sections 30 and 32 of the Louisiana Constitution of 1974, as amended, and La. R.S. 40:1502.1 and the applicable provisions of Chapter 5 and Chapter 6-A of Title 18 of the Louisiana Revised Statutes of 1950, as amended, and other constitutional and statutory authority, a copy of which is on file with the Parish Council of the Parish of Livingston, State of Louisiana, as governing authority of the Parish of Livingston, State of Louisiana (the "*Parish Council*").

WHEREAS, the District has made application to the Parish Council for approval to call and hold such election on Saturday, May 9, 2020, as more fully set forth in the District Resolution.

WHEREAS, Article VI, Section 15 of the Louisiana Constitution of 1974, as amended, and Section 1415 of Title 33 of the Louisiana Revised Statutes of 1950, as amended, grant power to the Parish Council to approve any proposal submitted by the District to levy a service charge.

NOW, THEREFORE, BE IT RESOLVED by the Parish Council, as the governing authority of the Parish of Livingston, State of Louisiana, that:

SECTION 1. Pursuant to a request submitted to this Parish Council by the District and in accordance with Article VI, Section 15 of the Louisiana Constitution of 1974, as amended and La. R.S. 33:1415, approval is hereby granted to the District to call and hold an election on Saturday, May 9, 2020, for the purpose of authorizing the levy and collection of a service charge in an amount not to exceed \$32.00 per annum for each single family residential structure, not to exceed \$100.00 per annum for each multi-family residential structure and not to exceed \$150.00 per annum for each commercial structure for a period of ten (10) years for the purpose of fire protection services (the "*Service Charge*"), in the manner conferred by Article VI, Section 32 of the Louisiana Constitution of 1974, as amended, La. R.S. 40:1502.1 and the applicable provisions of Chapter 6 and Chapter 6-A of Title 18 of the Louisiana Revised Statutes of 1950, as amended, and other constitutional and statutory authority and as more fully set forth in the District Resolution.

SECTION 2. In the event the foregoing propositions pass, approval, consent and authority are hereby granted to the District to levy and collect the Service Charge described in Section 1 hereof.

SECTION 3. This approval is granted in compliance with the provisions of Article VI, Section 15 of the Louisiana Constitution of 1974, as amended, and Section 1415 of Title 33 of the Louisiana Revised Statutes of 1950, as amended.

MOTION was offered by John Wascom seconded by Randy Delatte to publish the ordinance by title in the Official Journal in accordance with the legal mandates and set a Public Hearing for Thursday, February 6, 2020 at the hour of six-thirty (6:30) p.m. at the Parish Council Chambers in the Governmental Building located at 20355 Government Boulevard, Livingston, Louisiana, at which time comments will be received on the proposed ordinance prior to a Council vote.

The chair addressed agenda item 13, Office of Homeland Security and Emergency Preparedness:
a. Quality Assurance Panel recommendation: Acadian Ambulance contract renewal

Mr. Mark Harrell addressed the Councilmembers and advised that the Quality Assurance Panel members had met in reference to the Acadian contract. He advised that all but one (1) member was in attendance, and everyone, including himself, voted to renew the Acadian contract as it stands. He advised that there were three (3) or four (4) Acadian representatives on hand in the audience to answer questions from the Councilmembers, and he would be available as well if need be.

Councilman Randy Delatte requested to call upon Dwain Meche, Acadian Ambulance Governmental Liaison Community Relations Supervisor in the audience to answer his questions about response times in the lower part of his Council District.

Mr. Dwain Meche came to the lectern and advised Mr. Delatte that since he was last there, Acadian had added many resources to Livingston Parish, including rural responders and the aforementioned Quality Assurance Panel by Mr. Mark Harrell. He discussed the response times and answered Mr. Delatte's questions.

Councilman Maurice "Scooter" Keen discussed the same problems that the citizens of Watson were experiencing and praised Mr. Meche and Acadian Ambulance for their outstanding attempts in rural areas. Mr. Meche advised of the recent rural responder efforts and strides that had recently been implemented and all three (3) spoke of their hopes for proposed upcoming road projects.

MOTION was made by John Wascom and duly seconded by Tracy Girlinghouse to accept the unanimous recommendation submitted by the Livingston Parish Quality Assurance Panel to renew a four (4) year contract, known as Amendment #1 to Contract, with Acadian Ambulance Service, Inc. for emergency and non-emergency ambulance services for the Parish of Livingston; and also including any municipality choosing to participate via intergovernmental agreement; the renewal Agreement's term of four (4) years shall be beginning February 1, 2020 and ending on January 31, 2024.

Thereupon the chair declared that the Motion had carried and was adopted.

The chair addressed agenda item 14, “Request for Director of the Livingston Parish Convention and Visitors’ Bureau (Tourism Commission) to present informational update and discussion of changes in their Bylaws”.

Eric Edwards, the Director of the Livingston Parish Convention and Visitors’ Bureau, greeted the Councilmembers and citizens of Livingston Parish. He presented positive statistic reports from the Louisiana Lieutenant Governor’s office and the University of New Orleans who reported a one hundred eighteen million dollars (\$1,018,000.00) economic impact for 2019. He continued to give a very detailed to report of our tourism industry regarding occupancy tax, their budget numbers, forecasted growth for Livingston Parish, reported number of visitors for 2019, numbers of tourism employees, social media, studies being conducted of visitors and where they are traveling to, what our Parish is selling: Quality of Life, Food, Music, and Places for People to Grow their Families and Have a Great Place to Live. He discussed the benefits of Juban Crossing and the influx of retirees, the Parish’s waterways, Blue Ribbon Schools, low crime, and now we have shopping and health care. He foretold that the Parish is destined to become even better than now. He discussed the influx showing in their budget and wished to explain how they had received unexpected money from the BP oil spill. He continued to explain his conservativeness and what their hopes in these reserves could be used for, such as upcoming expansions into regional and international markets.

He invited the Councilmembers to ask any questions of him that they may have and advised that his door was always open. He also stated that he would love to come before the Council annually and present an updated report if they would allow him that objective.

Councilman Delatte asked how far the distances were that people were traveling to come to the Parish and also wanted to know about adding another tourism center closer to Bass Pro and Baton Rouge.

Councilman Keen requested how many tourists come into the center?

Mr. Edwards responded and answered all of their questions to their satisfaction.

Councilman Gerald McMorris wished to address Mr. Edwards and offer the use of Recreation District No. 5’s community center located a few miles up the interstate to the tourism center.

Mr. Edwards excitedly continued to tell of the many wonderful things that Livingston Parish had to offer.

He thanked the members for the opportunity to speak and the Councilmembers thanked him for coming and presenting his report.

The chair stated that he wished to move agenda item 22, “ Resolution to request the East Baton Rouge Metro Council to not support the resolution approving CAFA PILOTs for Morningside in which approves an annual payment in lieu of taxes to the Sheriff of Livingston Parish”, up from its position on the agenda, to which he met no opposition.

The chair called upon Councilman Garry Talbert to explain why he asked to put the item on the agenda.

Councilman Talbert advised that he received an email from East Baton Rouge Metro Councilman Trae Welch that asked why the governing authority of East Baton Rouge Parish were voting to eliminate property taxes in Livingston Parish. He further explained his discussion with Mr. Welch how “CAFA”, Capital Area Finance Authority, was structured. Mr. Welch had sent Councilman Talbert a Memorandum of Understanding between CAFA and the developer of Morningside. He explained that this is a pilot and CAFA, as a governmental entity, will acquire land and be exempt from ad valorem taxes and pay the Parish in lieu of ad valorem taxes one hundred and one dollars and thirty-five cents (\$101.35) each year for twenty (20) years in lieu of ad valorem taxes for a one hundred and twenty-five (125) unit apartment complex located off of Buddy Ellis Road. He further expounded to state that the Legislature expanded the boundary that CAFA could operate in, but did not change the governing authority, being the East Baton Rouge Metropolitan Council. Consequently, this parish governing authority could waive the Parish of Livingston’s property taxes, in lieu of a payment of one hundred and one dollars and thirty-five cents (\$101.35) to be split and divided among the Livingston Parish School Board, the Livingston Parish Sheriff’s office

and the Parish to get their share in lieu of receiving its normal property taxes. However, CAFA on the other hand, will be receiving an upfront one-time payment of twenty thousand dollars (\$20,000.00) and then an eighteen thousand seven hundred fifty-dollar (\$18,750.00) payment annually during the life of the pilot, plus the lease agreement. Councilman Talbert discussed the complications of not receiving revenue from those one hundred twenty-five (125) units. He discussed the language in the Memorandum of Understanding that stated that the pilot would operate the apartment complex for low to middle income citizens and they are going to sell Louisiana Housing Authority Low Income tax credits creating a competitive advantage for the individuals that own these apartments but it will be to the disadvantage of the Parish's revenues and budget.

Public input: Tom Delahaye: developer of Morningside; explained that this development is for senior citizens and not low to medium income multi-family residents

The chair allowed comments from each of the Councilmembers:

The chair called upon Councilman Randy Delatte. Councilman Delatte agreed with Councilman Talbert, however, he had a problem with adopting the resolution before them because it was a non-binding law and did not go far enough. He thought that there was a procedure when they gave up a tax, that it is done by ordinance, and if the Delegation made a mistake, possibly send them a resolution to place the Parish within the decision-making process. He further stated that if the Council does decide that is what they wish to do at later date, then use that procedure that the state government allows to give that tax break. He reiterated that a resolution is just the will of the Council and not a law and he did not want to be giving up a tax break at this time without enough information and no public hearings.

Councilman Gerald McMorris concurred and stated his opinions on what he had researched regarding this matter.

Councilman R.C. "Bubba" Harris shared that he did not want to do anything to the citizens of Livingston Parish that were fifty-five (55) and older and was in favor of the project.

Councilman John Wascom asked Mr. Moody if this was a program the state had approved that someone can build buildings in Livingston Parish and cut out all of our taxing that's apportioned for?

Mr. Moody instructed him yes. He continued to advise that he had not looked at this in great detail, but, he explained that this sets up a public housing trust, so the trust owns the property and they will allow certain things because they want to encourage certain housing needs.

The chair allowed a short open discussion.

Councilman Maurice "Scooter" Keen questioned if this was the same development that the Council had approve the preliminary plat on two (2) or three (3) years ago that they waive all parking on?

Public input: Tom Delahaye: answered Councilman Keen: waiver was to reduce the number of parking spaces to allow for more green spaces

The chair allowed an open discussion.

Councilman Tracy Girlinghouse questioned why the senior citizen verbiage was not included in the resolution?

Public input: Tom Delayhaye: answered Councilman Girlinghouse's questions
Gueydan Smith, Council District 3: questioned what happened if the property was sold by the developer?

The chair allowed follow-up comments from the Councilmembers.

The chair wished to end the comment period and share his concerns of the serious need for infrastructure on Buddy Ellis Road where the proposed development would be built.

WHEREAS, said resolution and the accompanying memorandum of understanding set the proposed annual payment in lieu of taxes to Livingston Parish tax entities at a very low amount and:

WHEREAS, there is local opposition to this arrangement since it will detrimentally affect the infrastructure and education resources for twenty years and:

WHEREAS, if the project is completed it will take out of private commerce the property in question which would likely be developed even without the tax exemption and;

WHEREAS, if the property in question is otherwise developed for private commercial use it can generate needed ad valorem taxes for the various Parish taxing entities;

THEREFORE, BE IT RESOLVED, that the Livingston Parish Council formally requests that the East Baton Rouge Parish Council reject the above resolution and deny the project hereafter.

THEREFORE, BE IT FURTHER RESOLVED by this Livingston Parish Council, that a copy of this resolution shall be forwarded to the East Baton Rouge Metropolitan Council.
