AN ORDINANCE TO PROVIDE THAT THERE SHALL BE NINE (9) COUNCIL MEMBERS, WHO SHALL EACH REPRESENT ONE (1) OF NINE (9) VOTING DISTRICTS, AND TO ESTABLISH AND PROVIDE FOR THE BOUNDARIES OF THE NINE (9) VOTING DISTRICTS

The following ordinance which was previously introduced in written form required for adoption at a regular meeting of the Livingston Parish Council on Thursday, April 14, 2011, a summary thereof having been published in the Official Journal together with a notice of public hearing which was held in accordance with said public notice, was brought up for final passage Thursday, May 12, 2011, on Motion of Ronald Sharp and seconded by Eddie Wagner:

## L.P. ORDINANCE 11-08

AN ORDINANCE TO PROVIDE THAT THERE SHALL BE NINE (9) COUNCIL MEMBERS, WHO SHALL EACH REPRESENT ONE (1) OF NINE (9) VOTING DISTRICTS, AND TO ESTABLISH AND PROVIDE FOR THE BOUNDARIES OF THE NINE (9) VOTING DISTRICTS

BE IT ORDAINED by the Council of the Parish of Livingston in regular session, duly convened, in keeping with the authority granted by applicable federal and state laws and regulations, and in order to effect reapportionment of its voting districts following the 2010 Census, that it does hereby enact an Ordinance.

The Council of Livingston Parish shall consist of nine (9) individuals qualified to hold the office, each of whom shall be domiciled in and elected by the voters residing in one of nine (9) voting districts as herein provided.

The voting districts of Livingston Parish shall be designated and shall each contain the precincts indicated as follows:

BE IT FURTHER ORDAINED that this Ordinance will become effective with the opening of the qualifying period for the primary election for members of the Council. Parish shall be divided into the Council Districts provided in this Ordinance for the purposes of election of members at the regular elections. These districts shall be effective for all purposes beginning the terms of the Council Members on the first Monday in January following their election.

The above and foregoing addition to the Code of the Parish of Livingston has been read in full, section by section, and was thereupon submitted to a vote, the vote thereon was as follows:
