WHEREAS, the Parish of Livingston owns the property described above, said property having been adjudicated to the Parish for unpaid property taxes for the year 1993 and assessed in the name of Burtis R. & Patty S. Rogers;

WHEREAS, the Department of Public Works for the Parish of Livingston has recommended that the property be declared surplus inasmuch as the Parish is not using the property and is not needed by the Parish;

WHEREAS, the Parish has a statutory duty to provide for the poor and necessitous pursuant to LSA-R.S. 33:1236(11), which includes special and remedial assistance to elementary and secondary school age children as well as neighborhood organization and improvement programs;

WHEREAS, Art. VII Sec. 14(B) of the Louisiana Constitution authorizes parish authorities to fund certain programs and provide services for the aid and support of the needy and Art. VII, Sec. 14 (C) of the Louisiana Constitution authorizes parishes to provide these services through cooperative endeavors with private corporations;

WHEREAS, Mighty Mom's, a Louisiana non-profit corporation, with an approved 501(c)(3) status, has been working with at risk children and children in need in Livingston Parish since 2010;

WHEREAS, Might Mom's operates programs to provide food for children through its "Full Tummy Project", literacy centers for after school educational instruction, and summer programs for these children;

WHEREAS Mighty Mom's desires to locate a metal building on the above described property to conduct these programs in Eastover Estates;

NOW, THEREFORE, BE IT ORDAINED by the Livingston Parish Council that:

1. LOT NUMBER ONE HUNDRED FORTY-ONE (141) EASTOVER MOBILE ESTATES FIRST FILING AS SHOWN ON A PLAT OF SURVEY BY E. E. EVANS & ASSOCIATES, INC., C. E. DATED SEPTEMBER 20, 1972 AND RECORDED COB 179, ENTRY NO.

94458 OF THE OFFICIAL RECORDS FOR THE PARISH OF LIVINGSTON

is hereby declared to be surplus inasmuch as the Parish is not using the property and is not needed by the Parish

- 2. The Parish President is authorized to execute an act of donation in which the Parish donates the above described property to MIGHTY MOM'S A LOUISIANA NON-PROFIT CORPORATION.
- 3. The act of donation shall specifically provide that the property is to be used solely for purposes declared herein and may not be sold, encumbered or otherwise transferred without the express written approval of the Parish.

The effective date of this ordinance shall be as prescribed by law.
