WHEREAS, Livingston Parish had previously purchased a tract of land from the Conservation Fund located in Sections 22, 26, 27, 34 and 35 of T9S-R6E, and Sections 2 and 3 of T10S-R6E, Southeastern Land District, East of the Mississippi River, Livingston Parish, and

WHEREAS, the previous Parish Council and administration had approved the purchase of this property, it did so by a resolution of the Council, LPR No. 06-660, and

WHEREAS, the Home Rule Charter and state law require that any purchase of property be done by an ordinance, and

WHEREAS, it is in the best interest of the Parish to correct this title problem.

THEREFORE, BE IT ORDAINED, by the Parish Council of the Parish of Livingston, State of Louisiana, that LPR No. 06-660 approving said purchase for the above-described property dated May 20, 2011, is hereby ratified by adoption of this ordinance.
