WHEREAS, the Livingston Parish Council was awarded Federal assistance under the Hazard Mitigation Grant Program; and

WHEREAS, the referenced ordinance stated \$324,750 as the offered amount, which was corrected; and

THEREFORE, BE IT RESOLVED, that the Livingston Parish Council acquired the following property at the corrected amount:

BE IT FURTHER RESOLVED, that the duly elected Parish President of Livingston Parish was authorized to sign any and all documents related to the acquisition of said property pursuant to the Hazard Mitigation Grant Program Project Number 4080-063-0001- Livingston Parish. Said property was purchased at 75% of the appraised value, which was previously stated at \$324, 750. The ratification of said property serves to correct the purchase price.
