A RESOLUTION OF THE BOARD OF SUPERVISORS OF JUBAN CROSSING COMMUNITY DEVELOPMENT DISTRICT, PARISH OF LIVINGSTON, STATE OF LOUISIANA (THE "DISTRICT") TO PROCEED WITH THE ISSUANCE AND SALE OF NOT TO EXCEED TWENTY TWO MILLION EIGHT HUNDRED TWENTY THOUSAND DOLLARS (\$22,820,000) AGGREGATE PRINCIPAL AMOUNT OF THE DISTRICT'S SPECIAL ASSESSMENT REVENUE BONDS, SERIES 2024 (THE, "SERIES 2024 BONDS") IN ONE OR MORE SERIES; DETERMINING AND AUTHORIZING CERTAIN DETAILS OF THE SERIES 2024 BONDS; AUTHORIZING THE EXECUTION AND DELIVERY OF A MASTER TRUST INDENTURE, AND A FIRST SUPPLEMENTAL TRUST INDENTURE, TOGETHER WITH AND ANY AND ALL OTHER DOCUMENTS AND CERTIFICATIONS RELATING TO THE ISSUANCE, SALE AND DELIVERY OF THE SERIES 2024 BONDS; FURTHER AUTHORIZING THE EXECUTION AND DELIVERY OF A BOND PURCHASE AGREEMENT WITH RESPECT TO THE SERIES 2024 BONDS; AND FURTHER AUTHORIZING THE PREPARATION AND DISTRIBUTION OF A PRELIMINARY AND FINAL LIMITED OFFERING MEMORANDUM; AUTHORIZING THE LIMITED OFFERING OF THE SERIES 2024 BONDS; ACCEPTING AND APPROVING THE DISTRICT ENGINEER'S CERTIFICATION AS TO PROJECT COSTS AND THE DISTRICT MANAGER'S REPORT CONCERNING THE ALLOCATION OF INFRASTRUCTURE COST AND ASSESSMENT METHODOLOGY; AND FURTHER PROVIDING FOR OTHER RELATED MATTERS IN CONNECTION WITH THE ISSUANCE OF THE SERIES 2024 BONDS.
