L.P. ORDINANCE NO. 24-22

AN ORDINANCE TO LEVY ADJUSTED MILLAGE RATES AFTER REASSESSMENT AND ROLL FORWARD THE MILLAGE RATES NOT TO EXCEED THE PRIOR YEARS MAXIMUM RATE FOR THE TAX YEAR 2024.

BE IT ORDAINED by the Livingston Parish Council, governing authority of the Parish of Livingston, State of Louisiana, in a public meeting held on September 12, 2024, which meeting was conducted in accordance with the Open Meetings Law, and the additional requirements of Article VII, Section 23 (C) of the Louisiana constitution and Louisiana Revised Statutes 47:1705 (B), et seq. and pursuant to Section 2-11 A(3) of the Home Rule Charter of the President-Council, that the Livingston Parish Council voted to increase millage rates but not in excess of prior year maximum rates on all taxable property shown on the official assessment roll for the year 2024, and when collected, the revenues from said taxes shall be used only for the specific purposes for which said taxes have been levied. Said millage rates are:

Section 2. The Assessor of the Parish of Livingston, State of Louisiana, shall extend upon the assessment roll of said Parish for the year 2024, and the taxes herein levied, and the tax collector of said Parish shall collect and remit the same to said taxing authority in accordance with the law.
